## **PUBLIC ANNOUNCEMENT**

### **RENEWAL OF EXISTING / NEW BUSINESS EMPLOYER IDENTIFICATION NUMBER (EIN)**

The Social Security Administration would like to inform the Public that effective December 1<sup>st</sup> 2020, all existing businesses and/or new businesses are required to come in to Social Security Office on December 1 through December 31, 2020 to renew its business Employer Identification Number (EIN) prior to renewal of National Business License at the Bureau of Revenue & Taxation.

Any Employer with outstanding Quarterly returns or SSA tax liability will have to clear all outstanding amounts prior to the renewal of EIN. If you know that you have any outstanding SSA tax liability and have failed to resolve them, you must contact the Administration and schedule an appointment regarding your delinquency. Having a settlement provides you with an opportunity to renew your business EIN.

Any business that fails to renew its EIN by the established deadline will not be eligible to obtain a business license at the Bureau of Revenue & Taxation and your business status will be "closed". This will prohibit the business and its representatives from engaging in any business transactions as set forth under **Chapter 15, 40 PNC.**

All EIN renewals are free of charge. Please visit our Office to complete all requirements to renew your business' EIN. If you have any questions, please contact us at 488-2457/1823.
